



Linear Magnetic Scale Magnets for AET-Series Sensors

NVE offers magnetic linear scale for use with AET-Series TMR Linear / Off-Axis Rotational Sensors. The magnetic linear scale can be purchased to be used in conjunction with the AG970-07E evaluation kit, and part number 12592 is included in the AG965-07E AET500 demonstration board.

The linear magnetic scale is single-track incremental, as shown below. This allows AET-Series Sensors to be used as incremental encoders.



The magnetic scale is lined with a protective stainless-steel backing. The stainless steel is backed with an adhesive.
